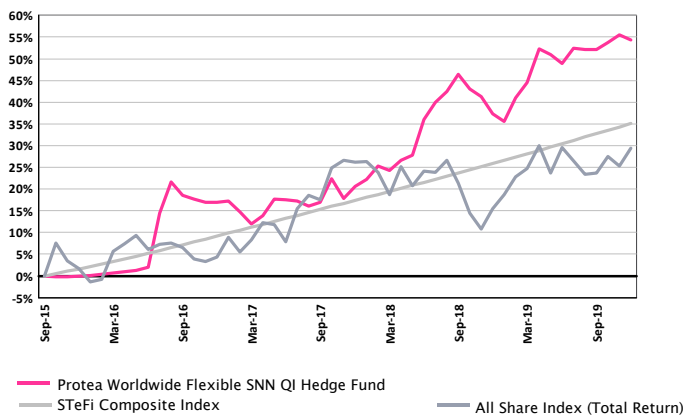
### Fund Profile

The fund is a flexible long/short equity hedge fund with the objective of generating above-average returns by following a 'quantamental' investment approach, combining traditional fundamental analysis with quantitative investment techniques. The investment manager systematically identifies individual mispriced securities whilst ensuring sufficient diversification to guard against inappropriate risk concentration. The fund has exposure to listed securities worldwide.

### Investment Strategy

The portfolio is managed as a long/short hedge fund, focused on extracting alpha returns from equity markets worldwide. Its core strategy is to be long undervalued equities and short overvalued equities whilst ensuring that there is sufficient diversification to guard against inappropriate risk concentration. The equities are selected by following a "quantamental" investment approach, which combines a traditional fundamental understanding of the fair value of listed equity shares with analysis of the business's competitive environment, economic growth, broad economic themes and relative valuations.

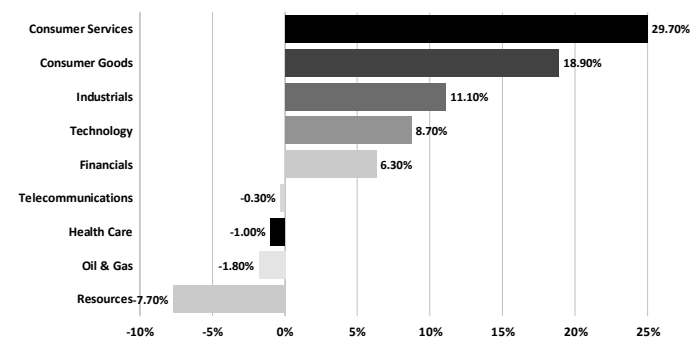

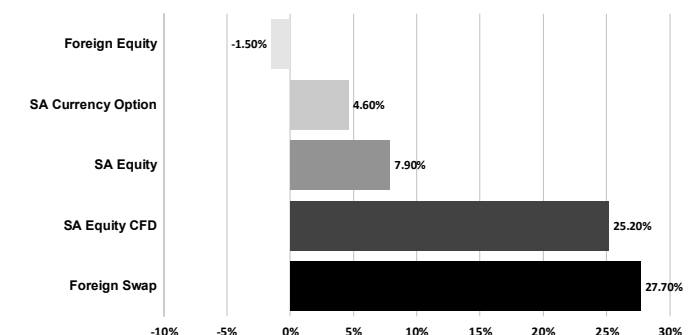
### Portfolio Objective

#### Market Commentary

To our surprise, the Rand (ZAR) rallied 4.6% against the US Dollar (USD) during December, from R14.67 to R14.00. This acted as a headwind to our reported performance, with the fund being down almost a percent in Rand terms. The MSCI World Index was down almost 2% in ZAR-terms but the FTSE/JSE All-Share Index returned 3.3% for the month. Our Longs contributed positively, but our other strategy categories (Shorts, Special Situations and Options) all detracted from performance.

Looking back at the year, we are reasonably satisfied with our performance. Our Longs added 16.8%, our Shorts detracted 2.1%, Special Situations detracted 0.2% and Options detracted 1.0%. Currency movements had a 1.2% negative impact for the year.

The contribution for the year, per instrument's listed currency (Longs, Shorts, Special Situations and Options combined), was as follows: Canadian Dollars +0.7%, USD +2.0%, British Pounds +0.6%, Euros +1.7%, Swiss Francs +1.1%, Danish Krone +0.6%, Norwegian Krone +1.3%, Swedish Krone +0.4%, ZAR +3.1%, Singaporean Dollars +0.2%, Hong Kong Dollars -0.1%, Japanese Yen +0.1% and Australian Dollars +0.6%. The fund's diversified return profile indicates that our 'quantamental' investment process is working well in practice. Our focus remains on generating above-average long-term returns for investors and we are building an impressive track record in this regard.
