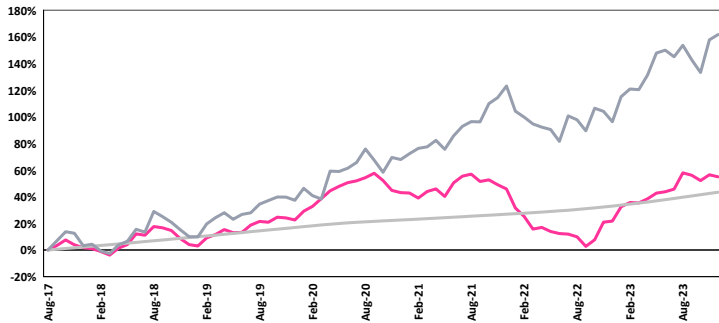
Fund Profile

The fund is a Global long/short equity hedge fund, domiciled in South Africa, with the objective of generating above-average returns by following a 'quantamental' investment approach, combining traditional fundamental analysis with quantitative investment techniques. The investment manager systematically identifies individual mispriced securities whilst ensuring sufficient diversification to guard against inappropriate risk concentration. The fund focuses on listed securities in developed markets outside of South Africa and has a net equity exposure of 35-70% at most times, with a maximum gross exposure of 200% (i.e. maximum 2x leverage).

Investment Strategy

The portfolio is managed as a long/short hedge fund, focused on extracting alpha returns from equity markets outside of South Africa. Its core strategy is to be long undervalued equities and short overvalued equities whilst ensuring that there is sufficient diversification to guard against inappropriate risk concentration. The equities are selected by following a "quantamental" investment approach, which combines a traditional fundamental understanding of the fair value of listed equity shares with analysis of the business's competitive environment, economic growth, broad economic themes and relative valuations.

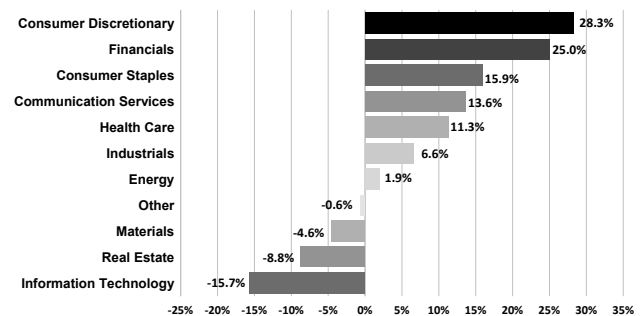

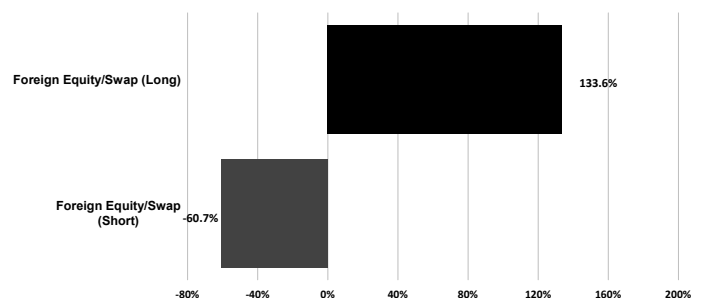
Portfolio Objective

Market Commentary

The fund slipped by 1.0% for the month of December, while the MSCI World Index rose by 1.5% in Rands (ZAR) and by 4.9% in US Dollars (USD) for the month (on a total return basis). The ZAR strengthened by approximately 2.5% against the USD over the course of December. In terms of our sub-strategies, Longs contributed 7.4%, Shorts detracted almost 6%, Special Situations chipped in 0.3%, Futures & Options detracted 0.4%, and Currency translation detracted 2.2% from the fund's reported return in ZAR. For the year, the fund returned 27.3% net of fees, while the MSCI World Index delivered a total gross return of 32.7% in ZAR.

Longs (grouped by listed currency) in Canadian Dollars (CAD), USD, British Pounds (GBP), Euros (EUR), Swiss Francs (CHF), Danish Krone (DKK), Norwegian Krone (NOK), Swedish Krona (SEK), Singaporean Dollars (SGD), Japanese Yen (JPY), and in Australian Dollars (AUD) contributed positively for the month. Longs (grouped by listed currency) in Hong Kong Dollars (HKD) detracted from December's performance. In a repeat of November, most of our Longs performed very strongly for the month, except for companies exposed to China. China-related stocks were a major disappointment for us in 2023, as was the case in 2022 as well. Sentiment towards the Middle Kingdom is now so negative, and expectations discounted in share prices so low, that we are optimistic about most Chinese stocks from current levels. For the year, Longs contributed almost 25% to the fund's performance.

No Shorts (grouped by listed currency) contributed positively for the month. Shorts (grouped by listed currency) in USD, GBP, EUR, CHF, DKK, NOK, and in SEK detracted from the fund's December return. As was the case in November, Shorts hurt us materially this month as many loss-making companies experienced strong share price performance on the back of interest rate cuts expected in the coming year. While 2023 was a tough year for our Shorts, detracting roughly 9% overall, we have managed to make a cumulative profit on Shorts over the past 2 years.

Special Situations made a small gain for the month, and contributed more than 5% for the year. Futures & Options detracted 0.4% for the month (and for the year) due to put option protection expiring out of the money. Currency translation was a headwind for December, since cash balances held in USD were translated to ZAR at a lower exchange rate. However, for the year, the weakening ZAR contributed just over 6% to the fund's reported return.

We were tracking roughly in line with the MSCI World Index's performance up to the end of October, but in the last two months of the year our Shorts detracted materially from the fund's return as stock markets around the world surged. We believe that the recent spike in the share prices of many loss-making companies is unsustainable, so Shorts could come back into their own during 2024.

Fund Risk

Leverage Risk:	The Fund borrows additional funds, trades on margin or performs short sale trades to amplify investment decisions. This means that the volatility of a hedge fund portfolio can be many times that of the underlying investments due to leverage on a fund.
Derivative Risk:	Derivative positions are financial instruments that derive their value from an underlying asset. Derivatives are exposed to implicit leverage which could result in magnified gains and/or losses on the portfolio.
Counterparty Credit Risk:	Counterparty risk is a type of credit risk and is the risk of default by the counterparty associated with trading derivative contracts. An example of counterparty credit risk is margin or collateral held with a prime broker.
Volatility Risk:	Volatility refers to uncertainty and risk related to size of change of an instrument or portfolio. It is a statistical measure of the dispersion of returns for a given security or market index. Volatility is proportional to the directional exposure of a portfolio and is measured by Value at risk (VaR) which is a statistical technique used to measure and quantify the level of volatility.
Concentration and Sector Risk:	A large proportion of total assets invested in specific assets, sectors or regions. Concentrated positions or concentrated sectors in a portfolio will material impact the returns of the portfolio more so than diversified portfolios.
Correlation Risk:	A measure that determines how assets move in relation to each other. Correlation risk arises when the correlation between asset-classes change. Correlation risk also arises when the correlation within an asset-class changes. Examples of correlation within asset classes include equity pairs trading, fixed income curve trading and commodities pairs trading.
Equity Risk:	The market price of shares varies depending on supply and demand of the shares. Equity risk is the risk of loss due to the drop in the market price of shares.
Currency/Exchange Rate Risk:	Assets of a fund may be denominated in a currency other than the Base Currency of the fund and changes in the exchange rate between the Base Currency and the currency of the asset may lead to a depreciation of the value of the fund's assets as expressed in the Base Currency.

Glossary

Net Asset Value (NAV):	Means net asset value, which is the total market value of all assets in a portfolio including any income accruals and less and deductible expenses such as audit fees, brokerage and service fees.
Annualised Return:	Is the weighted average compound growth rate over the performance period measured.
Highest & Lowest Return:	The highest and lowest rolling twelve-month performance of the portfolio since inception.
Total Expense Ratio (TER):	Reflects the percentage of the average Net Asset Value (NAV) of the portfolio that was incurred as charges, levies and fees related to the management of the portfolio. A higher TER does not necessarily imply a poor return, nor does a low TER imply a good return. The current TER cannot be regarded as an indication of future TER's.
Transaction Costs (TC):	Is the percentage of the value of the Fund incurred as costs relating to the buying and selling of the Fund's underlying assets. Transaction costs are a necessary cost in administering the Fund and impacts Fund returns.
Total Investment Charge (TIC):	Should not be considered in isolation as returns may be impacted by many other factors over time including market returns, the type of Fund, investment decisions of the investment manager.
Total Investment Charges (TIC%):	= TER (%) + TC (%): The Total Investment Charges (TIC), the TER + the TC, is the percentage of the net asset value of the class of the Financial Product incurred as costs relating to the investment of the Financial Product. It should be noted that a TIC is the sum of two calculated ratios (TER+TC).
Leverage/Gearing:	The use of securities, including derivative instruments, short positions or borrowed capital to increase the exposure beyond the capital employed to an investment.
Alpha:	Denoted the outperformance of the fund over the benchmark.
Sharpe Ratio:	The ratio of excess return over the risk-free rate divided by the total volatility of the portfolio.
Sortino Ratio:	The ratio of excess return over the risk-free rate divided by the downside deviation of the portfolio.
Standard Deviation:	The deviation of the return of the portfolio relative to its average.
Drawdown:	The greatest peak to trough loss until a new peak is reached.
Correlation:	A number between -1 and 1 indicating the similarity of the dispersion of returns between the portfolio and another asset or index with 1 being highly correlated, -1 highly negatively correlated and 0 uncorrelated.
Value at Risk (VaR):	Value at risk is the minimum loss percentage that can be expected over a specified time period at a predetermined confidence level.
