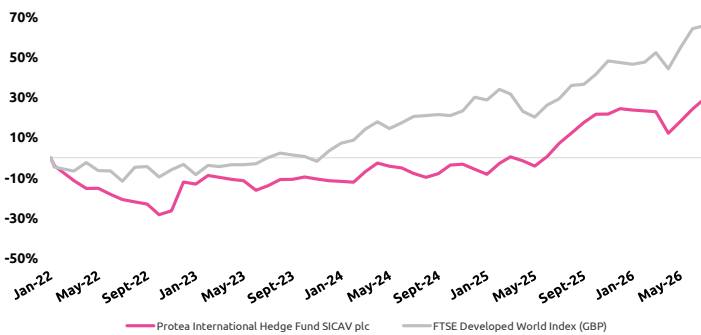
Fund Profile

The Protea International Hedge Fund SICAV plc ("Fund") is organised under the laws of Malta as a multi class public limited liability company with variable share capital (SICAV) pursuant to the Companies Act (Chapter 386 of the Laws of Malta). The Fund is licensed by the Malta Financial Services Authority ("MFSA") to carry out the activities of a collective investment scheme in the form of a professional investor fund targeting qualifying investors, with registration number SV576 and registered address at 36, Manoel de Vilhena Street, Gzira GZR1012, Malta. The Fund is approved by the Financial Sector Conduct Authority ("FSCA") in South Africa under Section 65 of the Collective Investment Scheme Control Act 2002 and has been categorised as a Collective Investment Scheme for public sale in South Africa. The investment manager systematically identifies individual mispriced securities whilst ensuring sufficient diversification to guard against inappropriate risk concentration. The fund focuses on developed market listed equities worldwide without any limitation to equities of a particular market sector, region, industry or market capitalization, with a maximum gross exposure limit of 400% (i.e. maximum 4x leverage).

Investment Strategy

The portfolio is managed as a long/short hedge fund. Its core strategy is to be long undervalued equities and short overvalued equities whilst ensuring that there is sufficient diversification to guard against inappropriate risk concentration. The equities are selected by following a "quantamental" investment approach, which combines traditional fundamental analysis with quantitative investment techniques.

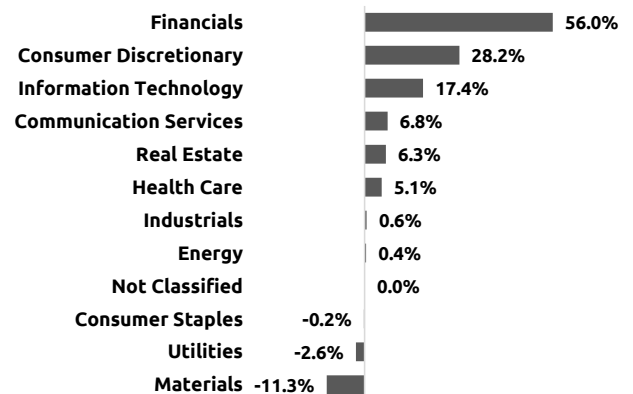

Market Commentary

The respective June net returns for the three Non-Institutional share classes of the fund were +2.9% in US Dollars (USD), +4.6% in Euros (EUR), and +4.1% in British Pounds (GBP). The FTSE Developed World Index, on a total return basis net of dividend tax, returned -0.8% in USD, +1.5% in EUR, and +0.8% in GBP over the same period.

In terms of gross sub-strategy attribution for the month, Longs contributed +3.1%, Shorts contributed +2.0%, and Special Situations detracted -0.5%. Futures & Options made no contribution during the month. Currency translation detracted from the USD-reported return but contributed positively to the EUR and GBP share class returns, as both currencies weakened against the USD during the month.

Longs listed in Canada, the USA, Great Britain, the Eurozone, Denmark, Norway, Japan, and Australia contributed positively for the month. Longs listed in Switzerland, Sweden, Singapore, and Hong Kong detracted from June's performance. Our top Longs for the month were a US semiconductor manufacturer, a US buy-now-pay-later operator, and a Japanese semiconductor equipment manufacturer. Our worst-performing Longs were two US enterprise software companies and a US social media company. Year-to-date, Longs have contributed +11.5% to the fund's return.

Shorts listed in the USA, Great Britain, the Eurozone, Norway, and Sweden contributed positively for the month. Shorts listed in Denmark and Switzerland detracted from June's performance. Our top Shorts for the month were a US autonomous vehicle company, a US automotive manufacturer, and a European automotive manufacturer. Our worst-performing Shorts were a German chemicals company, a Swiss speciality chemicals company, and a US life sciences group. Year-to-date, Shorts have detracted -2.8% from the fund's return.

Special Situations detracted slightly from the past month's performance and have detracted -2.6% year-to-date. The fund held no Futures & Options positions during the month, which have contributed +0.1% year-to-date. Currency translation has added +0.3% year-to-date to the fund's USD return.

Performance in June was supported by strong returns from our semiconductor-related holdings, while the Short portfolio also made a meaningful contribution. Although some of the fund's Long software and internet sector exposure lagged during the month, positive contributions across a broad range of sectors and geographies demonstrated the benefits of maintaining a diversified, benchmark-agnostic approach.

Fund Risk

Leverage Risk:	The Fund borrows additional funds, trades on margin or performs short sale trades to amplify investment decisions. This means that the volatility of a hedge fund portfolio can be many times that of the underlying investments due to leverage on a fund.
Derivative Risk:	Derivative positions are financial instruments that derive their value from an underlying asset. Derivatives are exposed to implicit leverage which could result in magnified gains and/or losses on the portfolio.

Correlation Risk:	A measure that determines how assets move in relation to each other. Correlation risk arises when the correlation between asset-classes change. Correlation risk also arises when the correlation within an asset-class changes. Examples of correlation within asset classes include equity pairs trading, fixed income curve trading and commodities pairs trading.
Equity Risk:	Applies to investment in shares or derivatives based on shares. The market price of shares varies depending on supply and demand of the shares. Equity risk is the risk of loss due to the drop in the market price of shares. Equity risk can either be systematic risk which is risk to the entire market based on political and economic indicators or unsystematic risk which is company specific and includes risk relating to company profits, future prospects and general consensus on the company or sector.

Net Asset Value (NAV):	Means net asset value, which is the total market value of all assets in a portfolio including any income accruals and less and deductible expenses such as audit fees, brokerage and service fees.
Annualised Return:	Is the weighted average compound growth rate over the performance period measured.
Highest & Lowest Return:	The highest and lowest rolling twelve-month performance of the portfolio since inception.
Total Expense Ratio (TER):	Reflects the percentage of the average Net Asset Value (NAV) of the portfolio that was incurred as charges, levies and fees related to the management of the portfolio. A higher TER does not necessarily imply a poor return, nor does a low TER imply a good return. The current TER cannot be regarded as an indication of future TER's.

Total Investment Charges (TIC%):	= TER (%) + TC (%): The Total Investment Charges (TIC), the TER + the TC, is the percentage of the net asset value of the class of the Financial Product incurred as costs relating to the investment of the Financial Product. It should be noted that a TIC is the sum of two calculated ratios (TER+TC).
Leverage/Gearing:	The use of securities, including derivative instruments, short positions or borrowed capital to increase the exposure beyond the capital employed to an investment.
Alpha:	Denoted the outperformance of the fund over the benchmark.
Sharpe Ratio:	The ratio of excess return over the risk-free rate divided by the total volatility of the portfolio.
Sortino Ratio:	The ratio of excess return over the risk-free rate divided by the downside deviation of the portfolio.
Standard Deviation:	The deviation of the return of the portfolio relative to its average.
Drawdown:	The greatest peak to trough loss until a new peak is reached.
Correlation:	A number between -1 and 1 indicating the similarity of the dispersion of returns between the portfolio and another asset or index with 1 being highly correlated, -1 highly negatively correlated and 0 uncorrelated.
Value at Risk (VaR):	Value at risk is the minimum loss percentage that can be expected over a specified time period at a predetermined confidence level.
